## Swimming Pool Regulations

The pool is operated for the use of the members of the Sudbury Finnish Rest Home Society and their guests.

### CAUTION

### THIS POOL IS NOT SUPERVISED.

**BATHERS LESS THAN TWELVE (12) YEARS OF AGE ARE NOT ALLOWED WITHIN THE POOL ENCLOSURE UNLESS ACCOMPANIED BY A PARENT OR THEIR AGENT WHO IS AT LEAST SIXTEEN (16) YEARS OF AGE.**

### ALSO

It is the policy of the society that a BUDDY SYSTEM is used by all persons for the sauna and pool.

#### **RULES:**

1. No person infected with communicable disease or having open sores on their body shall enter the pool.
2. No person shall bring a glass container onto the deck or in the pool.
3. No person shall pollute the water in the pool in any manner. Spitting of water and blowing the nose in the pool or on deck are prohibited.
4. No person shall engage in boisterous play in or around the pool.
5. Maximum number of bathers permitted on the deck and in the pool at any time is 34.
6. Note the location of telephone available for emergency use.
7. No food or beverage is supplied or consumed in the pool area.
8. Every bather shall take a cleansing shower using soap and warm water before entering the pool area.
9. NO DIVING

#### Please Note

Afternoon, evening and weekend building access is limited.

A key fob is required to access the pool and sauna area. You will receive a key fob with your Sudbury Finnish Rest Home Society membership. There is a \$10 refundable deposit for a key fob.
