Fitness Regulations

The fitness facilities are operated for the use of the members of the Sudbury Finnish Rest Home Society and their guests.

CAUTION

THE FITNESS FACILITIES ARE NOT SUPERVISED.

INDIVIDUALS LESS THAN TWELVE (12) YEARS OF AGE ARE NOT ALLOWED WITHIN THE FITNESS FACILITIES UNLESS ACCOMPANIED BY A PARENT OR THEIR AGENT WHO IS AT LEAST SIXTEEN (16) YEARS OF AGE.

ALSO

It is the policy of the society that a BUDDY SYSTEM is used by all persons for the fitness facilities.

RULES:

- 1. No person infected with communicable disease or having open sores on their body shall enter the fitness facilities.**
- 2. No person shall bring a glass container into the fitness facilities.**
- 3. No person shall pollute the Pool in any manner. Spitting of water and blowing the nose in the pool or on deck are prohibited.**
- 4. No person shall engage in boisterous play in or around the fitness facilities.**
- 5. Maximum number of bathers permitted in the pool and on the deck at any time is 34. Maximum number of individuals in the gym area is 30.**
- 6. Note the location of telephone available for emergency use.**
- 7. No food or beverage is supplied or consumed in the fitness area.**
- 8. Every bather shall take a cleansing shower using soap and warm water before entering the pool area.**
- 9. NO DIVING IN THE POOL.**

Please Note

A key fob is required to access the fitness facility. You will receive a key fob with your Sudbury Finnish Rest Home Society membership. There is a \$10 refundable deposit for a key fob.
